After some time when I was not able to handle Gautam Aggarwal's behavior, I confronted him for his ill & immoral behavior towards me, since then Gautam Aggarwal started using abusive language with me and I informed about the same to the Chairman Diwakar Aggarwal to take action against Gautam Aggarwal and to make team for protection of woman. However, no action was taken against Gautam Aggarwal for his ill behavior.
